

**EVALUATION/DEMONSTRATION BOARD KIT
LICENSE AGREEMENT**

IMPORTANT: By loading this software or any portion thereof, you agree to all of the terms of this Agreement. Do not load this software until you have carefully read and agreed to the following terms and conditions. AMD expressly reserves and does not grant any rights under any AMD patents or trademarks. All rights not expressly granted to DEVELOPER herein are reserved to AMD.

2. **NO SUPPORT OBLIGATION.** AMD is not obligated to furnish or make available to DEVELOPER any further information, software, technical information, know-how, show-how, or support. AMD reserves the right to make changes to the Materials without further notice.

3. **NO WARRANTIES, LIMITATIONS OF LIABILITY.** AMD IS PROVIDING THE MATERIALS TO DEVELOPER "AS IS, WITH ALL FAULTS." AMD MAKES NO WARRANTY WHATSOEVER, EXPRESS, IMPLIED, STATUTORY, CONTRACTUAL OR OTHERWISE WITH RESPECT TO THE MATERIALS, AND EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE OR NON-INFRINGEMENT AND ANY WARRANTIES ARISING BY VIRTUE OF CUSTOM OF TRADE OR COURSE OF DEALING.

No Obligation to Enforce. Nothing contained in this Agreement shall be construed as imposing on AMD any obligation to acquire, maintain, or file or defend any suit or action regarding the validity or infringement of, any AMD intellectual property licensed under this Agreement.

Compliance With Laws. DEVELOPER agrees to comply with all U.S. export regulations in connection with the marketing, sale and distribution of products licensed hereunder, including without limitation the Export Administration Regulations administered by the U.S. Department of Commerce and the International Traffic in Arm Regulations administered by the U.S. Department of State.

Relationship of the Parties. Nothing in this Agreement shall be construed to constitute either party as the agent, employee or representative of the other party.

Governing Law. This Agreement, and all of its provisions, shall be governed by and construed in accordance with the laws of the State of California, United States of America, without reference to conflict of laws' principles.

No Waiver. The waiver by either party of any breach of any provision of this Agreement shall not operate or be construed as a waiver of any other or a subsequent breach of the same or a different provision.

Severability. In the event that any provision of this Agreement is determined to be invalid, unenforceable or illegal, such invalidity, unenforceability or illegality shall not affect any other provisions of this Agreement, and the Agreement shall be construed as if the challenged provision had never been contained herein.
